An Ohio native, Ronald Rapini, MD, received a B.S. in Biology at the University of Akron and his M.D. at Ohio State University in 1978. He did his Transitional Internship at the Marshfield Clinic, Dermatology residency at University of Iowa and Dermatopathology fellowship at University of Colorado in 1983. He was faculty at the University of Texas, Houston and became the Chair in 1994 until 2002 when he accepted a position as Professor of Pathology at University of Texas Medical School and MD Anderson Cancer Center, Houston. His current title is Chernosky Distinguished Professor and Chair of Dermatology. Dr. Rapini's awards include Nickel Award for Teaching of Dermatopathology, Am Soc Dermpath, 2005; Annual Distinguished Service Award, Am Soc for Mohs Surg, 2009; Founder's Award, American Society of Dermatopathology, 2012 and Freeman Mentoring and Leadership Award, Texas Dermatological Soc, 2013. His publications include over 200 abstracts, books, and journal articles in addition to over 320 presentations at state, national and international meetings.
